2019/040 Chairman's welcome and opening remarks

2019/043 Minutes of the last meeting

2019/044 Clerks Report (for information only)

- a) The Play Area annual independent review took place in August for both the Carr Lane and Mere Brow play areas. There were no high risks reported. The reports have been passed to Yates Playground for review and any actions over medium and small risks highlighted. After these visits there was an accident reported whereby a child fell from a broken see-saw. The equipment was removed and fixed the same day. Further investigation indicates that the equipment was broken by an act of vandalism by teenagers
- b) Radar Speed Signs (RSS): Members asked the Clerk to investigate options to install one or more RSS's in the Parish. It was agreed that a formal agenda item with a proposal would be brought to the next meeting;
- c) WLBC Local Plan revision: Acland Bracewell has requested a meeting to discuss the implications of the decision of the Borough Council. Cllr R Bryan and the Clerk will attend when arranged.
